- 2. The anti-avoidance regime of business restructuring in the domestic legislation (comparative analysis between Italy and Germany)
- 3. Transfer pricing after cross-border business restructuring
- 4. Exit taxes and business restructuring
- 5. Business restructuring by transferring assets to foreign permanent establishments

The presentations will be discussed with the participants at the Seminar. English language will be used for all presentations, papers and debate.
